- Will be part of Project Management Team working on both ends Client & Vendors
- 3. Close coordination with Project manager, electrical engineer and civil engineer on each project to keep track of all client requests on FLN deliverables
- During Project execution stage, map all client requests against the contract with help of PM team and highlight the scope which is deviating from actual contractual obligation
- 5. Follow due process to inform client regarding scope change and estimate cost & time impact of scope change on the original contract conditions





- 6. Issue change order requests to Vendors based on scope change request received from Client. Coordinate with internal Commercial team to issue change order Purchase orders to vendor.
- 7. Evaluate Vendor Change order requests and validate them with support from members of PM team.
- 8. Weekly Status report to be shared internally as well as with client and vendors on each of the change order/scope change work.
- 9. Work closely with Commercial Project management team to improve Claims management by closely tracking
 - a. change orders with clients and vendors both
 - b. timelines of scope deliverables under change orders
 - c. payment receivables arising out of any change order job.
